1 Scope of Contract

This Contract comprises the provision of all necessary design and project professionals, materials and labour to carry out the design and renovation works of Design
Meeting Room at Partial Café Dining Area at Room W103, 1/F West Wing at Hong Kong Chu Hai College all as detailed on the Drawings, General Specifications and this Specification.

2 Site of Works

The site of Works is located at Partial Café Dining Area at Café, Room W103, 1/F West Wing, Hong Kong Chu Hai College, 80 Castle Peak Road, Castle Peak Bay, Tuen Mun, N.T. Hong Kong.

3 Terms of Payment

- 3.1 1st Stage: 20% Upon Commencement of design work mobilization
- 3.2 2nd Stage: 15% Upon Commencement of renovation site work mobilization
- **3.3** 3rd Stage: 20% Upon completion of demolition, plastering, conduit installation, and major base works like furring and flooring with written acceptance by HKCHC and the project consultant.
- **3.4 4**th **Stage:** 40% Upon acquiring practical completion (PC) with major works stated in the tender document completed with written acceptance by HKCHC and the project consultant. **3.5 5**th **Stage:** 5% Upon completion of 12 months of Defect Liability Period (DLP) with satisfaction and written acceptance by the project consultant and the College (HKCHC).

 *Total DLP is 12 months upon the 4th stage of practical completion date with PC certificate issued by the project consultant and confirmed by the Client.

4 PRELIMINARIES

Preliminary Items

- 4.1 The Preliminary Items included hereunder apply to the whole of the Works Constrained in this Specification and the amount inserted by the Contractor in the Summary of Tender shall be deemed to apply to the whole of the Works carried out under this Contract.
- 4.2 In event of no amount being inserted by the Contractor in respect of Preliminaries, in the Summary of Tender, the value thereof will be deemed to have been included in the cost of the work specified hereinafter following and no separate amount whatsoever will be certified for payment.

6.1 The Contractor's particular attention is drawn to the fact that the works to the premises under this Contract must be carried out in co-operation with and agreement of the supervisor of the premises to allow the reasonable operation of the premises and completed within the period stated on the Form of Tender.

7 Work included in Contract

- 7.1 The Contractor's prices for the items contained in the Contract shall be deemed to include the cost of the incidentals of labour, materials, all cutting and waste, packing's, cartage, risk, moving, hoisting and fixing in the required position, scaffolding, plant, ladders, platforms, supervision, profit and all things and matters necessary for the carrying out of and for the timely and satisfactory completion of the entire works contained in the Contract and Specification, such be expressed or not.




Floor Plan of 1/F Café





1/F Cafe MVAC Layout Plan







